

## NOTE TO CONTRIBUTORS

All materials submitted to the *Journal* must be original and must not have been submitted for publication elsewhere or be under consideration for possible publication by this *Journal*. Authors are not paid for accepted manuscripts. Accepted manuscripts must conform to *Journal of Demography* style requirements (see below). All submissions are subject to a normal double-blind peer review process by at least two reviewers in the field concerned. Accordingly, the title of the manuscripts and the name(s) of the author(s) and affiliation should appear only on a separate cover page in order to preserve anonymity during the peer-review process. Full correspondence details (street address, telephone and fax number, and e-mail address) of the corresponding author should be provided.

**Submission:** Ideally, the manuscript should be submitted in hard copy form with an electronic version on a CD to: Editor-in-Chief, *Journal of Demography*, College of Population Studies, Chulalongkorn University, Visid Prachuabmoh Building, Henri Dunant Road, Bangkok 10330, THAILAND. As the *Journal of Demography* processes manuscripts electronically, book reviews and related materials, submissions, correspondence, revisions, etc., can also be made by electronic exchanges over the Internet. Electronic versions of manuscripts, e.g. MSWord and PDF files, should be e-mailed to journal.cps@chula.ac.th.

All pages of the manuscript must be numbered. Manuscripts should include a structured abstract addressing the goals, methods, results, and conclusions of the study. The abstract should be accompanied by up to six key words or phrases that characterize the contents of the manuscript. The manuscripts should normally be between 3,000 and 5,000 words, including notes, and appendices. The number of references is limited to 30-40, except review articles, which may furnish more references. Acronyms and abbreviations should be defined in full at first mention and used consistently thereafter.

### Guidelines for paper format and fonts

The preferred typeface is Times New Roman, double spaced.

- a. Title: Font 14 point (bold); Name & Institute (font 12 pt); E-mail address (font 10 pt)
- b. Abstract: Font 12 pt (normal), including Key words (about 300 words)
- c. Text: Font 12 pt
- d. Footnotes: Font 10 pt (normal)
- e. Table: Font 12 pt (normal)
- f. Figure: Font 12 pt (normal)
- g. Appendices: Font 12 pt (normal)
- h. References: Font 12 pt (normal)

**Figures and tables** should be clearly drawn on separate pages and not included as part of the text. Each table and figure should be supplied in a separate file in the finished format suitable for reproduction. Please insert a location note, e.g., **Table 2 about here**, at the appropriate place in the text. Figures not created electronically should be drawn in black drawing ink on good quality white paper or board. The lettering should be large enough to enable the necessary reduction in size for printing. Figure legends should be provided separately on a page with that title to enable the compositor to edit them separately from the artwork. The author(s) must obtain permission for the reproduction of tables and figures from other sources in manuscripts.

**References:** All references to monographs, articles, and statistical sources are to be identified at an appropriate point in the text by last name of author, year of publication and pagination where appropriate, all within parentheses. The Harvard referencing system is used. References should be indicated in the text by the name and date system: either 'Recent work (Smith, 1984)...' or 'Recently, Smith (1984: 22)...'. If more than two authors are listed, cite the reference as 'Smith *et al.* (1984)...'. If no person is named as author, the name of the appropriate corporate body should be used: e.g. (National Bureau of Statistics of China, 2003). Footnotes are to be used only for substantive observations. A complete list of references arranged alphabetically by the first author should be included at the end of the manuscript. They should be complete in all details, including article, book and journal titles in full.

**Proofs:** Proofs will be sent to corresponding authors by e-mail. They should be corrected and returned to the publisher within three working days. Major alterations to the text cannot be accepted.

**Reprints:** Corresponding authors will receive a complimentary copy of the issue containing their manuscript. Reprints of manuscripts published in this journal can be purchased.

**Copyright:** The *Journal of Demography* has the right to first publication of all submitted manuscripts. Once manuscripts are accepted and published, all rights, including subsidiary rights, are owned by the College of Population Studies. The author retains the right to use his/her article without charge in any book of which he/she is the author or editor after it has appeared in the *Journal of Demography*.
